Clerk's Report – 25 September 2023

Update on outstanding items:

Replacement of the bin attached to the brick bus shelter in Aston Cross: The new bin has been ordered and is awaiting delivery – due 8 weeks.

Community Speedwatch: Initial training with an enforcement camera officer has been completed. Clerk finalising sites with Community Speedwatch team and arranging speed watch sessions with volunteers.

Defining and preserving community identities: Clerk investigating and awaiting feedback from Gloucestershire County Council.

Dog Bins for Pamington: A new dog bin has been installed on Pamington Lane. The Ellendene Road bin is due to be re-sited to replace damaged Pamington Lane dog bin (near back into Action) in the near future. Awaiting confirmation of installation date from TBC.

Parish defibrillators:

The refurbishment of the telephone box is being progressed.

Pamington and Barleyfields Traffic Questionnaire: The questionnaire results have been published on the website and Facebook and are due to be distributed to relevant highways teams.

Parish Noticeboards: Clerk organising new back board for Aston on Carrant. Refurbishment of recently removed The Meadows noticeboard ongoing.

B4079 Updates: Clerk investigating accident statistics on this road and how the 7.5 ton weight limit is enforced. Clerk liaising with chicken farm regarding access restrictions for heavy vehicles. Clerk has contacted Gloucestershire Highways to request a 'no left turn' sign is installed at the junction of B4079 and farm entrance.
