Clerk's Report – 19 August 2024

Updates on outstanding items:

- **Dog Fouling in Ashchurch:** Tewkesbury Borough Council (TBC) have confirmed the site had been added to their dog patrol area and provided details of suitable signage for ARPC to purchase. Clerk has also requested quote to lift canopy of trees to increasing visibility and prevent dog fouling - awaiting quotation.
- **Recruitment:** The recruitment campaign has been undertaken and interviews had been held. The position remains open.
- **Build Back Better funding: Camera and Signage:** All purchases have been made and delivered.
- **Child road safety signage in Barleyfields:** Clerk has contacted Gloucestershire County Council regarding their response to request made for permission to install sign. Response received stating an assessment will be arranged by developer. No assessment has been arranged to date.
- **Providing dog bins at St Nicholas' Church, Loverose Way and Fiddington Lane:** Clerk has placed order with Tewkesbury Borough Council. Due to TBC procurement delays, still awaiting confirmation of installation dates.

Current on-going projects / issues:

- **Defining and preserving community identities:** A successful meeting had been held between ARPC members and TBC regarding existing naming issues and future processes. Awaiting report from TBC.
- **Barleyfields green space to link with PROW and A46:** Clerk continues to liaise with National Highways regarding provision of safe access to Ashchurch.
- **Asset Inspection:** Clerk in process of collating inspection information.
- **Parish Noticeboards:** Refurbishment of recently removed The Meadows noticeboard ongoing.
- **Emergency Planning document:** Clerk liaising with councillors to create document.
- **Wooden village gateway signs:** Clerk liaising with local Highways to assess locations.
- **Vehicle Activated Signs (VAS) to be located on B4079:** Clerk has submitted application for partial funding for mobile VAS – awaiting outcome.
- **Replacement of the bin attached to the brick bus shelter in Aston Cross:** The new bin has been delivered and awaiting installation.
- **Rural Parish Council administration referencing:** Clerk investigating options.
- **Provisions of grit and grit bins in Parish:** Clerk liaising with Gloucestershire Highways regarding installation of grit bins at Barleyfields and Claydon Lane.
- **Flooding at Walton Cardiff:** Clerk liaising with Gloucestershire County Council to organise maintenance works.
- **Planning Breaches:** Clerk has raised this with the planning enforcement team. Awaiting feedback.
- **Community Litter Picking:** Clerk liaising with Tewkesbury Borough Council to organise.
