**TEMPORARY CLOSURE OF PUBLIC FOOTPATHS AAS 41 AND AAS 43**  
**(PARISH OF ASHCHURCH) TEWKESBURY BOROUGH**

NOTICE is hereby given that the Secretary of State for Transport has extended the Order to close temporarily under Sections 14, 15 and 16 of the Road Traffic Regulation Act, 1984 (as amended) part of the Public Footpaths as described below:

AAS 41 from its junction with the A46 opposite Austin Road at Ordnance Survey Grid Reference (OSGR) SO 9331 3333 generally south easterly for a distance of approximately 250 metres to a point where it crosses the Tirlle Brook at OSGR SO 9351 3316 and shown by a solid black line between points A and B on the Map

AAS 43 from its junction with the A46 at OSGR SO 9379 3351 generally southerly for a distance of approximately 144 metres to a point where it crosses the Tirlle Brook at OSGR SO 9384 3338 and shown by a solid black line between points C and D on the Map.

The closure is necessary to facilitate construction of a new housing development.

This temporary closure Order came into force on the 5<sup>th</sup> February 2018 and was extended by the Secretary of State until 4<sup>th</sup> November 2019. Works have still not completed and the Secretary of State has granted a further extension which will last until 4<sup>th</sup> August 2021 or until the works are complete, whichever is earliest.

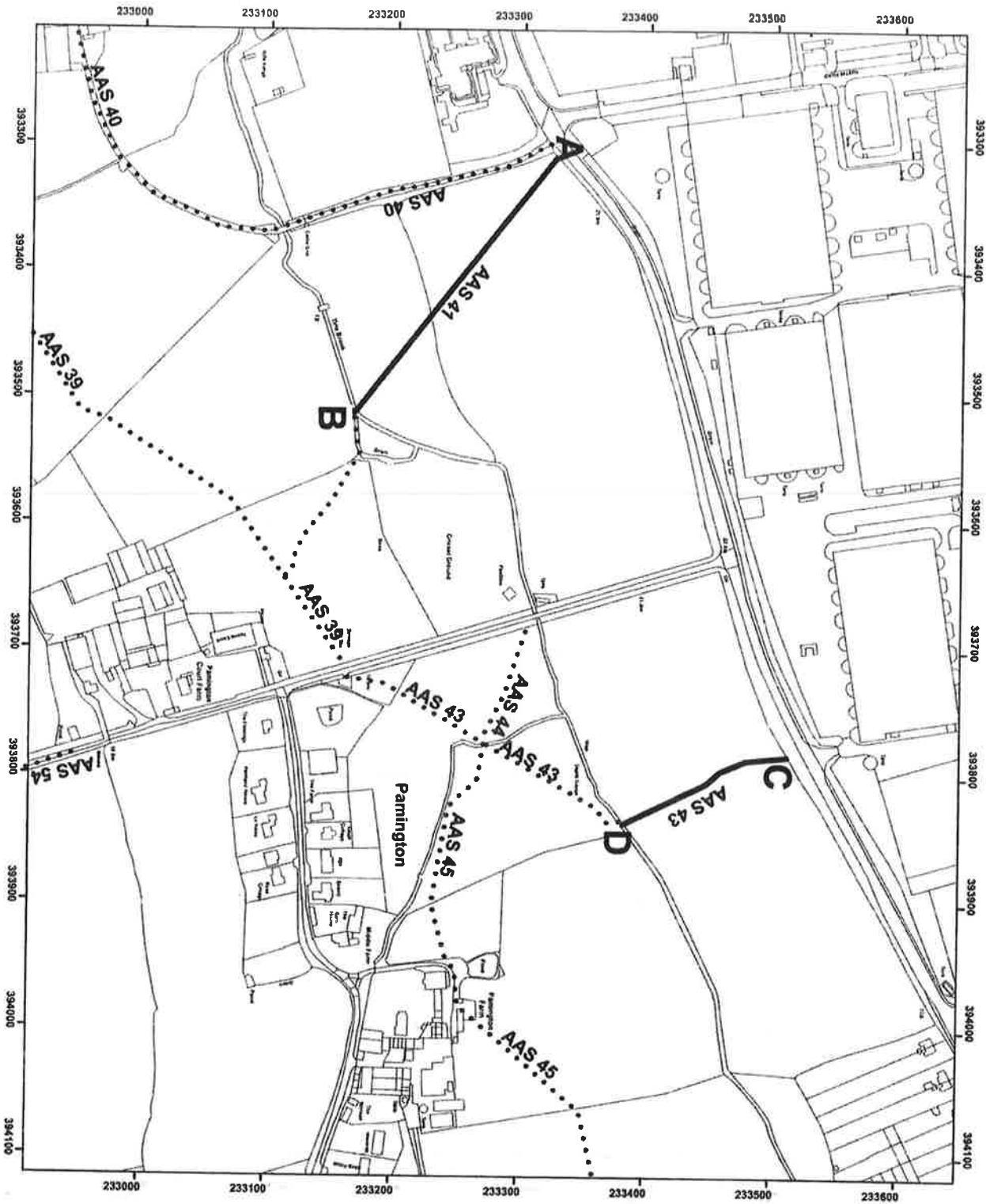
